Pursuant to the Administrative Order Establishing Procedures for Interim Monthly Compensation of Professionals [Docket No. 95], the Debtors’ estates are authorized to pay Blank Rome \$229,214.00, which represents 80% of the fees (\$286,517.50) and \$4,327.48, which
